In addition, Quincy served as a Law Clerk for the Legal Aid Foundation of Los Angeles, where he provided legal services to clients who were seeking assistance with public benefits, domestic violence, immigration, housing, and employment.

Quincy graduated Order of the Coif and received the American Jurisprudence Award in several classes, including Civil Procedure Patent Litigation, Core Competencies for Litigators, Constitutional Law, and Property. He also served on the board of the Southern California Law Review and on the executive board of the USC Business Law Advisor and will have a forthcoming article on patent law matters.
